KEY HIGHLIGHTS

2022

Business planning and key objectives were developed for all wholly owned companies (except for Acden Manufacturing) following SWOT/TOWS analysis.

Acden Environment started recycling batteries for one of their key clients and were able to provide a rebate of \$.21/lb. After changing recycling vendors, Acden Environment was able to raise the rebate from \$.21/lb. to \$.37/lb.

Acden Fleet engaged a local youth to support his battery recycling project. To date, the youth has recycled over 440 pounds of batteries, supporting both environmental sustainability and community involvement.

Acden Lemax improved operational efficiency through research into robotics and equipment automation.

Acden Tech Sonic has successfully installed and commissioned a waste water treatment plant at its Sherwood Park facility.

Acden Fleet has achieved over 867,000 hours LTI free in 2022 and has been LTI free for 12 years. Acden Manufacturing has been LTI free for 25 years (Since 1998). Acden Tech Sonic has been LTI free for 17 years.



2020 flood rebuild: Acden Facilities oversaw the remediation and rebuild of the Corporate Headquarters and Acden Fleet building. The project spanned over five months and 63,000 exposure hours recordable injury free.




ACDEN RECORDABLE INJURY


